Terms and Conditions of Membership

The rules of usage outlined below MUST always be followed, failing to do so will result in your membership being terminated.

1. WFCC operates a policy of zero tolerance with regards to aggression both physical or verbal towards its staff and volunteers, and will always ban users found to acting in this way and support the police in prosecution.
2. Members must be polite and considerate to other users and not act in an aggressive, abusive, anti-social or threatening manner towards any individual.
3. Smoking, including e- cigarettes are strictly prohibited in all areas of the gym.
4. Members may not bring any pets (other than official aid dogs) into the gym.
5. You may not use the gym whilst under the influence of alcohol, narcotics, tranquilizers or any medication or other substance which may affect your ability to exercise safely, this includes performance enhancement drugs.
6. When taking photos you should ensure these do not include other gym members within your picture.
7. Members are solely responsible for their own belongings whilst visiting WFCC Centre. WFCC Gym accepts no responsibility for any loss or damage to personal property.
8. Membership can be cancelled at any time, no refunds will be given for the period in which you are currently in.
9. Direct Debit membership should be cancelled by the 15th of the month to prevent the next payment been taken.
10. Membership periods begin on the first day of the month and end on the last day of the month at losing time that day.
11. Appropriate footwear must always be worn with in the gym
12. Ensure that you wipe down equipment after use
13. Please put your weights back in their original place when finished
14. Always be mindful of your own & others safety
15. No running in the shower areas
16. Leave showers in an acceptable state for the next user
17. Do not misuse the weights by dropping them on the floor
18. Only WFCA staff PTs are allowed to run PT sessions within the gym, using external PTS may result in membership being canceled
19. Anyone found to be operating coaching, personal training sessions in the gym will have their membership revoked and be banned from renewing

20. Always use all the gym equipment in a safe manner as instructed during Induction training.
21. Membership is non refundable
22. Membership is non transferable
23. The management reserve the right to revoke all membership
24. The management reserve the right to adjust the gym opening time
25. In extreme weather or emergency situations the management reserve the right to close the gym, no refunds will be issued for reduce access.
26. WFCC Gym reserves the right to remove you from the premises if it reasonable believes you are unfit to use the facilities.
27. Members suspected of assisting none members gain access to the gym without payment will have membership revoked
